Swing seats - Play area

The Clerk reported that the baby swing seat had been replaced. The larger swing seat was also in need of replacing so the Clerk was to order a replacement for this too.

Cllr G Pashley to liaise with the Clerk to get the repair looked at to see what needs repairing.

Drain – Over Norton Park main road

Cllr G Pashley reported that the drains in the village had been unblocked. Cllr H Biles, OCC stated that she would check to see if the Over Norton main road drain had also been unblocked.

Village Signage

Cllr H Biles, OCC reported that an order had been put in for a new 'Over Norton' village sign that had been taken away by an unknown source to be installed.

Quarhill Close

Footpath

It was reported at an earlier meeting that half of the path had been tarmacked. The other part will also need to be tarmacked due to the fact that it is too rough for wheelchairs and pushchairs to use. Cllr H Biles, OCC stated that she would investigate this and find out if OCC had undertaken this work.

1554 To discuss the possible installation of bollards on Choicehill Road

It was reported at a previous meeting that installing bollards could help to stop people and contractor vans from parking on the grass verge. This was causing damage to the grass at the edge of the road forming a dip, allowing water to run off the road and therefore working its way across onto the nearby residents' driveways. OCC had previously stated that the Parish Council would need to pay 50% of the total cost.

Cllr H Biles, OCC requested photos of the area from Cllr M Harrison and would investigate what could be done.

1555 <u>To discuss updating the Parish's website</u>

Cllr S Llewellyn offered to take over the hosting of the website and update the accessibility of the website free of charge.

1556 To discuss changing the bank account from Barclays to Unity Trust

It was decided to look further into how the new bank account works. The Clerk reported that she would get more information on online payment authorisation before the Council decide to go ahead.

1557 Noticeboards

The Clerk had obtained 3 quotations for the two new notice boards to be put on the bus shelter. It was decided to go with the Parish Notice Board Company quotation which was £530.00 plus VAT. The Councillors requested to see more information before a final decision is made i.e. photos of other notice boards that the company had already installed for other customers.

1558 <u>To receive Councillor reports and suggestions for future agenda items</u>

Cllr M Harrison reported that a resident had voiced a concern about speeding cars through the village. It was also mentioned that opposite the junction at the bottom of Choicehill Road was a dangerous spot where residents park their cars outside their houses making the road very narrow for cars to get through safely. Cllr H Biles, OCC stated that she would look into a possible solution i.e. 20mph signs and she would sought a quote for some solar signs to be installed.
